**A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF NEWBURG,  
CUMBERLAND COUNTY, PENNSYLVANIA, TO APPOINT A MEMBER TO THE  
RENTAL APPEALS BOARD**

**WHEREAS**, the Borough of Newburg (the "Borough") has enacted a Rental Licensing and Inspection Ordinance, Ordinance No. 2016-01 (the "Rental Ordinance"), and established a Rental Appeals Board as required by the Rental Ordinance; and

**WHEREAS**, Section 111.2 of the Rental Ordinance provides that members of the Rental Appeals Board are to be appointed by Borough Council; and

**WHEREAS**, the Borough desires to appoint a member to the Rental Appeals Board to fill a vacancy of the Rental Appeals Board; and

**NOW, THEREFORE, BE IT RESOLVED**, and it is hereby resolved by the Borough Council of the Borough of Newburg, County of Cumberland and Commonwealth of Pennsylvania that:


**Section 1.** Section 111.2 of the Rental Ordinance, the Borough Council of the Borough of Newburg hereby appoints Barry Starliper as a member of the Rental Appeals Board of the Borough of Newburg, Cumberland County, Pennsylvania with a one (1) year term of office that will expire on January 1, 2021.

**Section 2.** In the event any provision, section, clause, or part of this Resolution shall be held to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, such invalidity, illegality, or unconstitutionally shall not affect or impair the remaining provisions, sections, sentences, clauses, or parts of this Resolution it being the intent of the Borough Council of the Borough that the remainder of the Resolution shall be and shall remain in full force and effect.


**Section 3.** This Resolution shall be effective as of January 6, 2020.


